## 1. Booking Conditions

Booking for the funnmore event has to be completed online [www.funnmore.de](http://www.funnmore.de) Once booked the Terms and conditions of funnmore will automatically apply. Bookings will be dealt with in accordance with the date received in the office. The funnmore confirmation will be sent to the email address given. If it is not received contact should be made with the organiser through [evelyn@ewendt.com](mailto:evelyn@ewendt.com). Participation in the funnmore event is only possible by booking and staying in ‘Liberty Hotels Lykia’ or Sentido ‘Lykia Resort and Spa’. The participant is responsible for booking their own flight and hotel. The booking is deemed binding.

## 2. Group Bookings

Group bookings are possible. Every eleventh person booked will be free of charge. The bookings are deemed binding and include the christian name and surname of each participant. Use of a group booking is confirmed by the signature of the main booking person. It is not allowed to send separate booking forms. The main booking person is responsible for complying with the terms and conditions, giving information to their group participants and is the contractual partner of the organizer. The invoice will be sent by email. It is the responsibility of the main booker that the customer has received it. Please make sure the email addresses are correct and legible. Bookings are paid by transfer after the invoice has been sent.

## 3. Payment

The invoice will be sent to the given email address. Make sure that the email address is correct and legible. Bookings are only payable by bank transfer once the invoice has been received. Invoice and payments will be registered according to the date received. Payment is due at least 10 days before the event. ## 4. Conditions of cancellation

The booking is binding. After booking there are no refunds possible. However, you are able to nominate a replacement person. In case of illness a doctor’s certificate must be shown and a voucher will be sent for the amount paid for the following year’s funnmore event. No money will be returned and the voucher is not allowed to be used by any other person.

## 5. Liability

Liability for persons and Liability for persons and property damage at the event funnmore is excluded from the scope of the legal possibilities. The participation in the event is at your own risk. We recommend a health check from a doctor in advance

## 6. General terms and conditions

- a) a) The invoice is the confirmation. The organiser of funnmore shall in no case be liable for directions, change of schedules and spaces, especially not if the booking and participant is not identical.
- b) If for reasons of force majeure in the event takes place, the organizer is not obligated to make any compensation. However, an alternative date will be offered.
- c) The organizer reserves the right to change the programme. The organizer will announce any short-term changes of content, location areas and presenters. and the announced expert.
- d) Photos and Videos are not permitted without the agreement of the organiser and presenter. The organiser of funnmore is permitted to take photos and film videos to use in future occasions. By booking the participant allows himself to be filmed or photographed. The photos und films can be used by the organiser funnmore without asking permission from the participant. If the participant does not agree to being photographed he/she will inform the organiser before the event takes place.
